_____ is my micro-chip number, you can find it on my neck. I am healthy, have had the first vaccination and should have the next booster by 12 weeks of age. Please avoid taking me out to areas frequented by other dogs until after I have had my second vaccination.

My human-mom told me that I am going to a loving, caring home and is therefore writing up this contract to protect me.

_____ agrees to keep the German Shepherd confined from traffic with access to a fenced yard or a kennel, to be properly sheltered, with adequate food and water. (Please note that I the breeder recommends: feeding one full bag of good quality puppy food then switching to an adequate adult dog food). Your pup has been eating "First Mate Puppy Food". To provide adequate exercise, some form of obedience training, and to provide regular veterinary care. Never allow the GSD to ride in the open bed of a pick-up, ranchero, jeep, or other similar vehicle unless the GSD is crated or otherwise properly restrained.

If a health problem is detected by a licensed veterinarian within 5 working days from the receipt of the puppy, the puppy may be returned to Josephine Studer/Doucette for a refund of the full purchase price, excluding shipping. A signed statement from the examining licensed veterinarian detailing the health problem has to be provided to Josephine Doucette.

If the new owner is ever charged or convicted of animal abuse or cruelty by a federal, provincial, state or local authority, the owner forfeits all right to the above named GSD and will immediately remand custody of the GSD to Josephine Doucette. All CKC registration papers to accompany the GSD the transfer section properly signed. In this case the purchaser will NOT receive any refund of monies paid to the seller.

I, Josephine Studer/Doucette, agree to register _____ with the CKC and forward the registration papers to _____

The new owner agrees to the **non-breeding agreement** from the CKC. It is recommended that you spay or neuter your pup. However, please be advised to not neuter your male pup until it has reached its maturity at 18 months of age if you are planning to use your male pup as a true working dog.

If the new owner would like to use the GSD for breeding purposes the GSD **must** have completed health testing at the age of two years. Health testing will include: hips checked for hip dysplasia and elbows as well by either or both OFA and OVC. If Josephine Studer/Doucette is satisfied with the results, the temperament of the dog, has completed its Obedience Level One as well as Obedience Level Two, and has demonstrated its ability to perform personal protection work the non-breeding agreement will be lifted.

If the GSD is used for breeding purposes without the above named conditions for the release of the non-breeding agreement fulfilled, the new owner agrees to pay the seller Can. \$ 5000.00 in damages.

The breeder offers a 2 year health guarantee for any life-threatening genetic diseases within the breed. Upon discovery of the genetic disease proven by a competent Vet, the buyer has a choice of a full refund or another pup/dog in the future. Proof has to be provided to Josephine Studer/Doucette that will be forwarded to her own Vet which he or she will have to verify in order for the refund to be valid. Under no circumstances is the breeder responsible for any Vet care or bills otherwise accrued, including proof of the genetic disease.

The breeder, to the best of her/his knowledge is providing the buyer with a healthy well-matched puppy. The puppy has been veterinary checked, dewormed, micro-chipped, and received its first set of puppy shots. Booster shots are recommended at 12 weeks, 16 weeks and, the last one, a year later.

I, Josephine Studer/Doucette will also provide future breeder support.

If, for any reason, the new owner can no longer keep the GSD, Josephine Studer/Doucette is to be contacted and will have first rights to the GSD.

No provisions in this contract may be altered or amended without the written approval of both the seller and the purchaser.
